Almost all mainstream manufacturers now offer electric vehicles. There are already hundreds of part or fully electric vehicles available in the UK with this number increasing daily.

With the government committed to the removal of all new internal combustion engines, now is the time to migrate your fleet to electrification.



Plug-In Hybrid (PHEV)

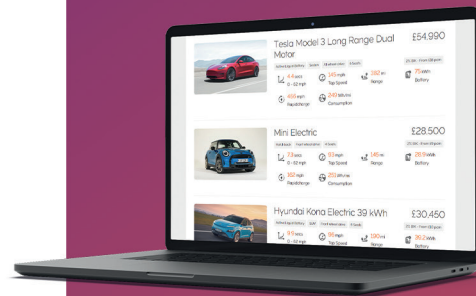
Plug-In Hybrids use rechargeable batteries, combined with an on-board engine to provide power for the vehicle. This improves efficiency and reduces emissions.



All-Electric (EV)

All-Electric cars are powered by electric batteries alone. This means they have to be charged before you can drive them. As a combustion engine is not used they produce zero tailpipe emissions.

Ultra Low Emissions

EVs are zero-emission vehicles meaning that they produce zero CO₂ when running the vehicle. Emissions may still be produced in the generation of electricity, but figures suggest this is up to 40% less than a conventional petrol or diesel car.

Low Cost

Electric motors have fewer parts such as no spark plugs, radiators, oil filters or exhausts. This could mean you have reduced maintenance, time and cost.

EVs and PHEVs are also exempt from the charge for entering Low Emission Zones. Many major cities across the UK have their own low emission zones launched or planned in the coming years.

BENEFITS

Company Car Tax

Switching to a fully or part electric vehicle can have a significant impact on a drivers Benefit in Kind tax. A driver will currently pay just 2% of the P11D value for a fully electric car while plug-in hybrid drivers can expect to pay between 5-14%, depending on the electric range.

One of the biggest worries for drivers making the switch to electric is range anxiety.

More than enough range for most drivers

A study has shown that the average weekly commute is **only 89 miles**. Data from **MiNextEV.co.uk** shows most EVs have a range well in excess of 200 miles.

Fast growing infrastructure

There are over **35,000 charging locations** in the UK, that is **more locations than petrol stations and growing**. The UK government has already committed to increase this every year up to 2030.

Smart apps

There are also **route planning apps** that work like Google Maps such as 'Zap-Map' and **www.abetterrouteplanner.com** that will take into consideration the range of your car and will assist you with where you should stop to charge your car and for how long.

Improved charging speeds

Due to improved technology, many vehicles can now charge from 10-80% in circa 20 mins on an ultra-fast charger.

Peer to peer charging

Businesses like Co-Charger make sharing home chargers easy for those who don't have access to their own off-road parking.

CHARGING OPTIONS



3 Pin 230V Wall Outlet

Electric vehicles can be charged by plugging into a standard 3 pin wall socket. For a PHEV, this type of charging on average takes between 6 to 8 hours and overnight for a medium range EV.



Rapid Public Chargers (DC)

Rapid chargers can be found in motorway service stations, supermarket and other roadside locations. They can provide between 50kW and 150kW of power through networks such as BP Pulse and Instavolt. These will fully charge all EVs between 30 and 60 Minutes.*

*Rapid charging speeds are reduced once the battery reaches 80% to preserve the battery



EV Charging (AC)

AC chargers can provide power between 3.6kW and 22kW, they can be installed at home or a work place and can be found at many public charging points. Typically they will fully charge a PHEV in 2 to 3 hours and for a medium range EV in 4 to 6 hours.

Our partners including BP Pulse offer schemes that give access to their network of thousands of rapid chargers across the UK, often at a reduced rate.

Other providers such as All Star offer payment cards to charge EVs, similar to how a traditional fuel card would pay for petrol or diesel.

CHARGING INFORMATION

Charging an electric vehicle should be treated the same as charging your mobile phone.

You should not let your vehicles battery run down to zero, instead you should charge it regularly for shorter periods of time. This will reduce the amount of time you will have to wait charging your car and reduce the risk of damaging your car battery.

Rapid chargers will charge your car at full speed to 80%, then reduce charging speed to protect car batteries.

They will then continue to charge to 100% at a lower speed.



Charging at home

Home chargers can charge between 3.6kW and 22 kW and can be bought and installed at your home or workplace.



Our home and workplace charging partner ChargedEV are able to install a choice of chargers to suit your needs.
