For protection of farmers' income and to reduce state's burden, a comprehensive coverage and expansion of the Pradhan Mantri Fasal Bima Yojana, using multi-stakeholder approaches as championed by some states, could be fruitful. 2

CITIES & SUSTAINABLE INFRASTRUCTURE

The progress in satisfaction with public transport (SDG11), highlighted the as Sustainable Development Report 2023 compared to 2022, could be enhanced by focusing on improving seamless first and last-mile connectivity to public transport services.

Walking is а healthy. economical and ideal choice for citizens adopting 'sustainable LiFEstyles for Environment'. Thus, the promotion and **prioritization** of pedestrian-friendly cities could provide an enabling environment for the same.

CLIMATE FINANCE

Extend support to states with high assessed vulnerability indices (like flood, disaster, heat stress prone) through financial mechanisms such as the National Adaptation Fund. This initiative could serve as a milestone achieving national targets by supporting SAPCCs.

CLIMATE JUSTICE & HUMAN RIGHTS

Climate-induced displacement is a devastating reality, especially the rise of slow onset climate events. Enabling policy mechanisms to address the challenges including rehabilitation & access to essential needs & services, could safeguard the most affected communities. 3

CLIMATE EDUCATION, SKILLING & GREEN JOBS

NEP 2020 holds immense potential to bring positive changes in Environmental Education, however, **local contextualization of resources and emphasis on teacher training program**s could provide teachers with exponential motivation and create a cascading effect.

Green Jobs for Youth Pact, launched at COP27, is being designed and implemented by the ILO, UNEP and UNICEF, active involvement of stakeholders in India could achieve a great impact.

LAND, OCEAN, FOOD & WATER

Establishing a Ecosystem Restoration Fund to offer support to local actors and incentivize community leaders for restoration could be a highly beneficial initiative.

Enabling the youth to remain and pursue their livelihoods along the coasts necessitates the promotion of a blue economy, grounded in comprehensive community-based studies. This approach holds the potential to reduce migration, offering the necessary support for continuity and creating a conducive environment for sustained livelihoods.

CLIMATE ACTION PLAN

To ensure comprehensive inclusion, it is imperative to **prioritize the engagement of communities and youth in stakeholder consultations** during the revision of State Action Plans on Climate Change.
