1. Purpose

1.1 This Copyright & Limited Use License Notice (“Notice”) sets out the legally binding terms under which certain materials made available via this Google Drive folder may be accessed and used.

1.2 Use of the Materials is strictly limited to purposes directly connected with the Hacktropica Event and only for the duration specified in Clause 4.2.

2. Scope of Application (“Materials”)

2.1 “Materials” means **anything and everything contained within this Google Drive folder**, whether uploaded prior to or after the Effective Date.

2.2 Without limitation, the Materials include:

- 2.2.1 Visual identity, branding, and marketing assets
- 2.2.2 Designs, illustrations, UI/UX files, wireframes, and prototypes

3.3 Nothing in this Notice shall be construed as transferring ownership, title, or intellectual property rights.

3.4 All rights not expressly granted under Clause 4 are **fully reserved** by the Owner.

4. Limited License Granted

4.1 Subject to full compliance with this Notice, the Owner grants the Hacktropica Core Team a **limited, non-exclusive, non-transferable, non-sublicensable, revocable license** to use the Materials.

4.2 Duration:

The license is valid strictly from **1 January 2026 to 31 May 2026 (inclusive)** and shall automatically expire thereafter in accordance with Clause 9.1.

4.3 Permitted Purpose:

Use of the Materials is permitted **solely** for:

- 4.3.1 Hacktropica event planning
- 4.3.2 Hacktropica-related promotion
- 4.3.3 Execution and operation of the Event
- 4.3.4 Post-event wrap-up directly related to Hacktropica

4.4 Authorized Users:

Only individuals who are:

- 4.4.1 Members of the Hacktropica Core Team, and
- 4.4.2 Explicitly granted access via Google Drive permissions

may access or use the Materials.

4.5 This license constitutes permission to use only and **does not constitute an assignment or transfer of rights**.

5. Strict Restrictions (Prohibited Uses)

5.1 Except as expressly permitted under Clause 4, and unless prior written permission is obtained from the Owner, the following actions are strictly prohibited:

5.2 Unauthorized Disclosure:

Sharing, transmitting, or disclosing the Materials to any individual or entity not covered under Clause 4.4.

5.3 Public Publication:

Publishing, uploading, displaying, or showcasing the Materials on websites, social media platforms, portfolios, communities, repositories, or marketplaces, except where expressly approved for Event-specific outputs under Clause 4.3.

5.4 Unrelated Use:

Using the Materials for any purpose unrelated to Hacktropica, including personal, academic, freelance, or commercial use.

5.5 Commercial Exploitation:

Selling, licensing, sublicensing, renting, distributing, monetizing, or otherwise exploiting the Materials or any derivatives thereof.

5.6 Rights Management Interference:

Removing, altering, obscuring, or tampering with copyright notices, attribution, watermarks, ownership metadata, or embedded rights information.

5.7 Derivative Reuse:

Creating derivative works intended for reuse beyond Hacktropica without the Owner's prior written authorization.

- 9.2.2 All copies stored outside this Google Drive folder (including local devices, backups, messaging platforms, and personal storage) must be permanently deleted
- 9.2.3 Written confirmation of deletion must be provided upon request by the Owner
