## 4. PHYSICAL AND SAFETY DATA

Fineliner with water-based ink, four writing colours, excellent cap-off time, metal-rimmed elastic plastic nib for comfortable writing. Casing and ventilated cap made of polypropylene. Line width 0.3 mm (fine) and 0.7 mm (medium), suitable for work with rulers.

When stored and used properly, no hazardous reactions can be expected. In case of fire, carbon monoxide (CO), carbon dioxide (CO<sub>2</sub>) and with some colours nitric oxides (NO<sub>x</sub>) will be set free as thermal decomposition products.

When not used properly, some colours may stain the skin, mucous membranes or clothing and fabrics. In some materials, the stain might be permanent.

In case of contact with the eyes, rinse out open eye thoroughly under running water for several minutes. If complaints persist, contact an ophthalmologist.

Based on the Regulation (EC) No. 1907/2006 („REACH“), this commercial product is not a hazardous substance, a hazardous mixture or a hazardous substance in an article. Therefore a Safety Data Sheet is not required according to article 31 of the REACH Regulation.

The writing instruments may be added to the household waste in small quantities.

Only small quantities of dyes are contained in the inks. They are, however, very durable- on account of their intended use and therefore biodegradability in normal conditions in sewage works or in surface waters is difficult. They can, however, be sufficiently adsorbed in the activated sludge and eliminated from the water.
