5. Fire-fighting measures

Suitable extinguishing media The product is not flammable. Extinguish with alcohol-resistant foam, carbon dioxide, dry powder or water fog. Use fire-extinguishing media suitable for the surrounding fire.

Advice for firefighters

Protective actions during firefighting Avoid breathing fire gases or vapors. Evacuate area. If a leak or spill has not ignited, use water spray to disperse vapors and protect men stopping the leak. Control run-off water by containing and keeping it out of sewers and watercourses. Methods and material for containment and cleaning up

Methods for cleaning up Wear protective clothing as described in Section 8 of this safety data sheet. Clear up spills immediately and dispose of waste safely. Eliminate all ignition sources if safe to do so. No smoking, sparks, flames or other sources of ignition near spillage. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurized contents and propellant. Small Spillages: Wipe up with an absorbent cloth and dispose of waste safely. Large Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. Alternatively, or if it is not water-soluble, absorb the spillage with an inert, dry material and place it in a suitable waste disposal container. Flush contaminated area with plenty of water. Precautions for safe handling

Usage precautions

Keep out of the reach of children. Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Avoid exposing aerosol containers to high temperatures or direct sunlight. Do not handle until all safety precautions have been read and understood. Do not handle broken packages without protective equipment. Do not spray on an open flame or other ignition source. Pressurized container: Do not pierce or burn, even after use. Spray will evaporate and cool rapidly and may cause frostbite or cold burns if in contact with skin. Avoid contact with eyes. Avoid inhalation of vapors and spray/mists.

Advice on general occupational hygiene

Wash promptly if skin becomes contaminated. Take off contaminated clothing and wash before reuse. Wash contaminated clothing before reuse. Do not eat, drink or smoke when using this product. Wash at the end of each work shift and before eating, smoking and using the toilet. Change work clothing daily before leaving workplace.

Provide adequate ventilation.
