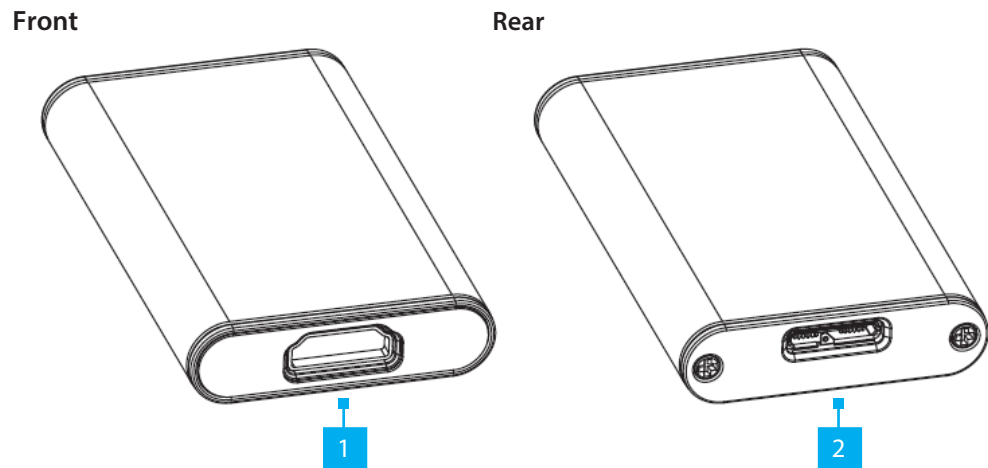


## UVC HDMI® Capture Device - USB-A/USB-C - 4K 30Hz - Windows and Mac

### Installation

#### Install the Capture Device

1. Connect an **HDMI Cable** from the **Video Source** to the **HDMI Input Port** on the **Capture Device**.
2. Connect the **USB Host Cable** to the **Capture Device**, and to the **USB Port** on the **Host Computer**.

**NOTE:** A SuperSpeed USB 5Gbps (USB 3.2 Gen 1) or higher host port is required for optimal performance.

3. Your computer automatically installs the necessary drivers when the capture device is connected.

**NOTE:** No software is included with the 4K30-HDMI-CAPTURE. The capture device works with third-party software (e.g. Teams, Zoom, and OBS) that supports **USB Video Class (UVC)** devices.

## Regulatory Compliance
