






### Installation

#### Software Installation

- 1. Using a web browser, visit the StarTech.com Product Page for the **USB-C Hub** by
  - www.StarTech.com/5G2A1SGBB-USB-C-HUB
- Click the **Drivers/Downloads** tab on the Product Page.
- 3. Under **Driver(s)**, download the Driver Package for your operating system.

#### Windows

- 1. Right-click the zip folder that was downloaded and select Extract All, then follow the on-screen instructions.
- 2. In the list of extracted files, right-click the **Setup(.exe)** file and select **Run as** Administrator.

**Note:** If the **Run as Administrator** option is not available, it's likely that the installation file is attempting to be ran from within the zipped file. Please extract the files using the instructions in Step 5.

3. Follow the on-screen prompts to complete the software installation.

#### macOS

- 1. Double-click the zip folder that downloaded, macOS will unzip the folder using **Archive Utility.**
- 2. In the list of extracted folders, select the folder that corresponds to your version of macOS.
- Double-click the installation package (.dmg file).
- 4. Follow the on-screen instructions to complete the software installation.

#### Hardware Installation

- 1. (Optional) Connect the **Tethered USB-C to USB-A Adapter** to the **Built-In USB-C** Host Cable, located on the USB-C Hub.
- 2. Connect the Built-In USB Cable, located on the USB-C Hub, to an available USB **Port** on the **Host Computer**.
- 3. Connect USB peripherals the **Downstream USB Ports**.
- 4. Connect an RJ-45 terminated network cable (CAT 5e or better) from your local area network (e.g. Router, Switch, Modem, etc.) to the Gigabit Ethernet Port, located on the **USB-C Hub**, to access a network via a wired LAN connection.
- 5. Connect a USB-C power adapter (up to 100W, sold separately) from an AC outlet to the 100W Power Delivery Pass-Through Port on the **USB-C Hub**, to charge the **Host Computer** that's connected to the **Built-in USB** Host Cable.

**Note:** The **Host Computer** must support USB-C Power Delivery on the **USB-C Port** that the **USB-C Multiport Adapter** is connected to, in order to charge the computer via USB-C.

6. Connect an RS-232 serial device to the RS-232 Serial Port.
