





Installation

Connect the Console

Note: Power off all **Computers, Displays, and Peripherals** before completing the following steps.

1. Connect an **HDMI Cable** (sold separately) from the **Console HDMI Output Port**, located on the rear of the **KVM Switch**, to an **HDMI Display**.
2. Connect a **USB Mouse** and a **USB Keyboard** to the **Console USB HID Ports**, located on the front of the **KVM Switch**.
3. (Optional) Connect a **USB-C Power Adapter** to the **USB-C Power Delivery Pass-through Port** for **PC 1**, located on the rear of the **KVM Switch**.

Note: If a **USB-C Power Adapter** is not connected to the **USB-C Power Delivery Pass-through Port**, the host will not charge through the **KVM Switch** connection.

4. (Optional) Repeat **Step 3** for **PC 2**

Connect the PCs

1. Connect the included **USB-C Host Cable** from the **PC 1 USB-C Host Port**, located on the front of the **KVM Switch**, to an available **USB-C Port** on **PC 1**.

Note: For full functionality the **Host Computer USB-C Port** must support **DP-Alt Mode and Power Delivery**

2. Connect the included **USB-C Host Cable** from the **PC 2 USB-C Host Port**, located on the front of the **KVM Switch**, to an available **USB-C Port** on **PC 2**.

Push Button Operation

Press the **Push Button Selector** to switch between **PC 1** and **PC 2**
