
- LWG-43CL installs into LW40-42-43UxP models;
- LWG-48CL installs into LW46-47-48UxP models;
- LWG-55CL installs into LW49-50-55UxP models;
- LWG-70CL installs into LW65-70UxP models;
- LWG-75CL installs into LW75UxP models.

NOTE: Available monitor space is reduced by 0.25" (6.25mm) for kiosks with glass installed.





ASSEMBLY

IMPORTANT!: It is best to install the glass into the kiosk front cover while it is still in the box, and the box is resting on a flat surface.

- 1. Place the kiosk (still in packaging) on a flat surface. (See Figure 1)
- 2. Open so that wall bracket is at a 90° angle from the swing door.
- 3. Keeping the wall bracket at 90°, slide the wall bracket about 1 inch towards bottom of kiosk until hinge pins clear the hinges, and move the wall bracket away from the swing door. (See Figure 1)



 Remove and SAVE four Phillips screws, loosen four thumb nuts and remove hinged frame from swing door. (See Figure 2)



- Clean the inside frame of the swing door with an alcohol wipe or something similar where the tape (C) and felt pads (B) will be attached, and let dry. (See Figure 3)
- Evenly space and apply the six felt pads (B) to the inside swing frame (halfway on the bottom extending halfway up the swing door).

 Remove one side of the adhesive tape liners and apply the tape pieces along the sides towards the top of the swing door. (See Figure 3)



Clean the glass (A), ensuring that the area where the adhesive tape will attach is clear of any dirt, dust and oils. Installation Instructions LWG-43-48-55-70-75CL

9. Place the glass in the swing door with the glass resting on the bottom of the door with the edge against the felt pads.

NOTE: Be sure to place glass with arrow in lower right corner pointing to top of swing door. (See Figure 4)



- Lay the glass down to test the fit within the swing door, and make sure that the area at the top matches with the location of the tape (C). (See Figure 5)
- 11. Slightly lift the glass enough to remove the tape liners and lay the glass down on top of the tape.
- 12. Apply 40-50 lbs of force for 5 minutes to ensure the bond between the tape and glass.
- 13. Apply the monitor gasket to the edges of the opening to the glass as desired. (Refer to kiosk installation manual.)
- 14. Make sure the visual area of the glass between the monitor and back of glass is clean.
- Install the monitor and proceed with installation as outlined in the kiosk installation manual.


