This guide outlines ASSA ABLOY Group's contributions to LEED in the Materials & Resources category.

Credit Categories

MR Credit: Building Product Disclosure and Optimization (1 pt)

- Credit Requirement (Disclosure): Use at least 20 permanently installed products sourced from at least five different manufacturers with EPDs.
- Contribution: ASSA ABLOY has Type III EPDs (valued at 1.5 products each).
- Credit Requirement (Optimization): Use at least 10% by cost (or 10 products from three manufacturers) with Life Cycle Impact Reduction Action Plans (50% value) or Life Cycle Impact Reductions in Embodied Carbon (100 200% value based on reductions).
- Contribution: ASSA ABLOY is currently working towards having life cycle impact reductions in embodied carbon.

MR Credit: Building Product Disclosure and Optimization – Sourcing of Raw Materials (1 -2 pts)

- Credit Requirement: Use products sourced from at least three/five manufacturers for at least 20/40% by cost of total value of permanently installed building products (1/2 pts) with responsible sourcing and extraction criteria (Extended producer responsibility, Reused materials, Recycled content).
- Contribution: ASSA ABLOY products covered by a take-back program and/or with recycled content contribute value to this credit.

MR Credit: Building Product Disclosure and Optimization – Material Ingredients (1 - 2 pts)

- Credit Requirement (Disclosure): Use at least 20 different permanently installed products from at least five manufacturers that use material ingredient reporting methods to at least 1000 ppm (1 pt).
- Contribution: ASSA ABLOY has products with HPDs or Declare labels and 7 third-party verified versions (worth 1.5 products each).
- Credit Requirement (Optimization): Use permanently installed products from at least three different manufacturers or 10 total products that document their material ingredient optimization.
- Contribution: ASSA ABLOY third party verified HPD/Declare Labels to 100 ppm with no GreenScreen LT-1 hazards/Red List Ingredients qualify.

Pilot Credit: Circular Products (1 pt)

- Credit Requirement: Use at least five permanently installed products from three manufacturers demonstrating one of the listed circular product report categories.
- Supply Chain Circularity
- Requires disclosure of what products the recycled content in products came from, currently not feasible.

Zero Waste Manufacturing

• Requires no more than 10% of waste be sent to landfill or incineration, Norton Rixson products would qualify for this credit.

Designed for Circularity

• Requires cradle-to-grave EPD for product and publicly available take back, re-use, disassembly, or material recovery instructions. ASSA ABLOY products with EPDs from facilities with take back programs would contribute.

Closed Loop Products

• GreenCircle Certified Closed Loop certification, currently no products with this certification.
