Kippap CE Online Review Program Terms and Conditions Agreement

1. Review Services and Platform Access

Kippap agrees to provide civil engineering review services to students preparing for the Civil Engineering Licensure Examination. These services include access to a range of learning materials, such as recorded video lectures, physical handouts, books, and online practice assessments, along with a messaging platform to connect with Kippap instructors.

2. Review Program Schedule and Progression Requirements

Kippap's CE Review Program is designed around structured progression milestones to ensure thorough preparation. The program includes the following key phases:

- 4) Pre-board Exam 1
- 5) Refresher

Each phase builds on the previous, offering a comprehensive and strategic approach to exam preparation. To begin, you must complete the Learner Profile before proceeding further. Access to lecture videos and assessments is granted only after completing the Diagnostic Exam. Similarly, students must complete Pre-board Exam 1 to unlock the Refresher materials. Failure to complete the exams, may result in restricted access to subsequent course materials.

Please be aware that selecting the Transfer Option will result in the deactivation of your current account with us, thereby restricting access to our review materials and video lectures. Minimum Laptop Requirements:
