



## ONLINE REVIEW PROGRAM TERMS AND CONDITIONS (CIVIL ENGINEERING LICENSURE EXAMINATION)

These **TERMS AND CONDITIONS** govern the Online Review Program offered by **KIPPAP LEARNING CORP.**, a domestic corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal office address at 42 K-1st St., Kamuning, Quezon City (hereinafter referred to as “**KIPPAP**”) to You, the **STUDENT**, an enrollee in **KIPPAP’s** Online Review Program (each of **KIPPAP** and the **STUDENT**, a “Party”, and collectively the “Parties”).

### SECTION 1. REVIEW SERVICES AND PLATFORM ACCESS

**KIPPAP** agrees to provide the **STUDENT** civil engineering review services in preparing for the Civil Engineering Licensure Examination. These services are provided through an Online Review Program, hereinafter referred to as the “**PROGRAM**.” The **PROGRAM** includes: (a) access to a range of learning materials, including, but not limited, recorded video lectures, physical handouts, books, and online practice assessments, and; (b) a messaging platform to connect the **STUDENT** with **KIPPAP** instructors.

To facilitate these services, **KIPPAP** utilizes various online platforms, including, but not limited to, the proprietary Student Portal, Mobile App, Web App, and third-party applications such as Discord and Zoom. The **STUDENT** is responsible for registering and managing his or her accounts on all platforms, including Discord and Zoom, to ensure access to **KIPPAP’s** review materials. Familiarity with each platform is recommended for a seamless learning experience.

Access to the **PROGRAM** shall commence after payment has been made in accordance with Section 3 of these Terms and Conditions and shall last until the day before the first examination day of the APRIL 2026 CELE, unless enrollment is transferred or extended, or is otherwise terminated, in accordance with the pertinent provisions of these Terms and Conditions.

### SECTION 2. REVIEW PROGRAM PROGRESSION REQUIREMENTS

The **PROGRAM** is designed around structured progression milestones to ensure thorough preparation. It includes accomplishing the following key phases on the Kippap Web App:

#### 1) Know Your Customer (KYC) Questionnaire



- 2) Diagnostic Exam
- 3) Review Proper (access to lecture videos and assessments and/or Daily Live Lectures)
- 4) Pre-board Exam 1
- 5) Refresher
- 6) Pre-board Exam 2
- 7) Final Coaching

Each phase builds on the previous, offering a comprehensive and strategic approach to exam preparation. **The STUDENT must accomplish the above phases in the order provided.** For example, the STUDENT must begin the PROGRAM by completing his or her KYC. Access to lecture videos and assessments shall be granted only after completing the Diagnostic Exam. Failure to complete the exams may result in restricted access to subsequent course materials.

The progression requirements outlined here are general guidelines and may vary depending on the specific package you have selected.

SECTION 3. PAYMENT

The STUDENT agrees to pay KIPPAP the following fees for the PROGRAM as outlined:

The **STUDENT** shall be given full access to the **PROGRAM** only after he or she has paid either the full payment or the first payment for monthly installment.

Should the **STUDENT** avail the monthly installment option, the **STUDENT** agrees to make timely payment of each installment (i.e., payment is made one month after the last payment made). Timely payment of each installment is necessary to maintain access to the **PROGRAM**. Should the **STUDENT** fail to make a timely payment of an installment, his or her access to the **PROGRAM** shall be suspended after due notice. Access shall be restored only after payment has been made.

#### **SECTION 4. CHANGES IN MATRICULATION**

The **STUDENT** acknowledges that his or her chosen package is non-negotiable and non-refundable, unless otherwise agreed upon by the Parties.

##### **A. Change of Package**

- a. **Upgrade of Package** – The **STUDENT** may request for an upgrade of his or her selected package. An upgrade refers to converting the selected package to a higher tier package (e.g. Final Coaching Package to Full Package). Upgrading shall be allowed subject to **KIPPAP**'s approval of the **STUDENT**'s request. Should the request be approved, the **STUDENT** must pay the balance between the selected package and the higher tier package based on the prevailing rates of the latter at the time the request is approved.
- b. **Downgrade of Package** – The **STUDENT** may not request for a downgrade (i.e., converting the selected package to a lower tier package) of his or her selected package.



## **B. Transfer Enrollment to Kippap CELE MAR/APR 2027 Review Program**

A **STUDENT** who avails of the Kippap CORE Package + Refresher, Kippap PRO Package + Refresher, or Kippap ELITE Package + Refresher + Care Package shall be eligible to Transfer Enrollment to the next batch of the **PROGRAM** for the next Civil Engineering Licensure Examination. This option is available from the time of enrollment until **July 31, 2026**.

Should the **STUDENT** wish to exercise the option to Transfer Enrollment, an additional fee of **Php 3,000** will apply if he or she has been enrolled for more than two weeks. However, should the **STUDENT** be enrolled for two weeks or less, no additional fee will be charged.

The **STUDENT** is advised that should he or she opt to Transfer Enrollment, the **STUDENT's** access to the **PROGRAM** will be deactivated until the commencement of the next batch.

## **C. Extension of Enrollment**

Starting **August 1, 2026**, the option to Transfer Enrollment shall no longer be available. However, the **STUDENT** may opt to Extend Enrollment for an additional fee of **Php 5,750** until **September 2, 2026**. This option is available to a **STUDENT** who avails of the Full Package.

Should the **STUDENT** wish to exercise the option to Extend Enrollment, the **STUDENT** shall be able to access the **PROGRAM** until the day before the CE Board Exam. After this date, the **STUDENT's** access to the **PROGRAM** shall be deactivated until the commencement of the next batch.

## SECTION 6. EQUIPMENT FOR ONLINE REVIEW

The **STUDENT** is advised that certain specifications of devices are essential for attending the **PROGRAM's** live online sessions and viewing of the lecture videos.

### Minimum Laptop Requirements:

- Processor: 4-core processor (e.g., Intel Core i3/i5/i7 or AMD equivalent)
- Operation System: Latest version of Windows 10 or macOS
- RAM: At least 8 GB
- Storage: Minimum 256 GB SSD
- Webcam, Microphone, and Speakers: Standard web camera, microphone, and speakers (or a headset)
- Internet Connection: Stable internet connection with at least 10 Mbps download speed

### Additional Considerations:

- Battery Life: Ensure the laptop has a decent battery life to last through longer study sessions
- Screen size: A screen size of at least 13 inches is recommended for comfortable viewing
- Durability: Look for a laptop that is durable and can withstand regular use



## Minimum Mobile Phone Requirements

- Processor: Qualcomm Snapdragon 665 or equivalent.
- RAM: Minimum 4GB (recommended: 6GB or more).
- Storage: Minimum 128GB (recommended: 256GB or more).
- Display: HD resolution (720p) or higher, with a screen size of at least 6 inches.
- Battery: Minimum capacity of 3000mAh.
- Operating System: Android 10 or newer, or one of the two most recent iOS versions.

**KIPPAP** shall not be held liable for any technical issues that may arise by not meeting these specific requirements.

## SECTION 7. COMMUNICATION

**KIPPAP** shall utilize Student Portal, the Kippap Web App and Mobile App for all announcements and reminders. In case of any downtime on these platforms, **KIPPAP** shall post updates in our Discord server.

It is the **STUDENT's** sole responsibility to ensure that he or she has access to these platforms and is able receive the necessary notifications. **KIPPAP** shall not be held liable for any missed sessions due to the **STUDENT's** inability to access updates.

## SECTION 9. STUDENT OBLIGATIONS, BEHAVIOR, AND DISCIPLINE

The **PROGRAM** is a learning environment dedicated to preparing students for the Civil Engineering Licensure Examination. The **STUDENT** is expected to conduct himself or herself appropriately throughout the duration of the **PROGRAM**. The **STUDENT** shall observe proper decorum at all times and shall refrain from inappropriate actions, which include, but are not limited to:





- Disruptive behavior during live sessions, including unnecessary noise, inappropriate screen sharing, or persistent interruptions
- Using offensive language, making inappropriate comments, or engaging in harassment or bullying towards instructors or fellow students in any program platform
- Unauthorized sharing of access credentials, recording, or distribution of class materials
- Violating **KIPPAP's** intellectual property rights or using program platforms for unrelated/commercial activities
- Failing to maintain professional conduct, including disregarding warnings to modify disruptive behavior

The **STUDENT** shall be apprised of any violation of this Section. Continued violation despite the warning shall result in the **STUDENT's** expulsion from the **PROGRAM**, without prejudice to **KIPPAP's** right to avail of and exercise any and all legal remedies and protections provided by law, which include, but is not limited to, the filing of administrative, civil, and criminal actions as the case may be. Refunds shall not be allowed in case of expulsion.

Lost printed handouts may be replaced for a fee of **Php 500**, exclusive of shipping costs.

## **SECTION 12. LIMITATION OF LIABILITY**

**KIPPAP** shall not be held liable for any damages arising out of or related to the review services provided under the **PROGRAM**.

**KIPPAP** reserves the right to, at its sole discretion, amend, modify, and/or revise these Terms and Conditions at any time and for any reason deemed necessary.
